### Investment Philosophy

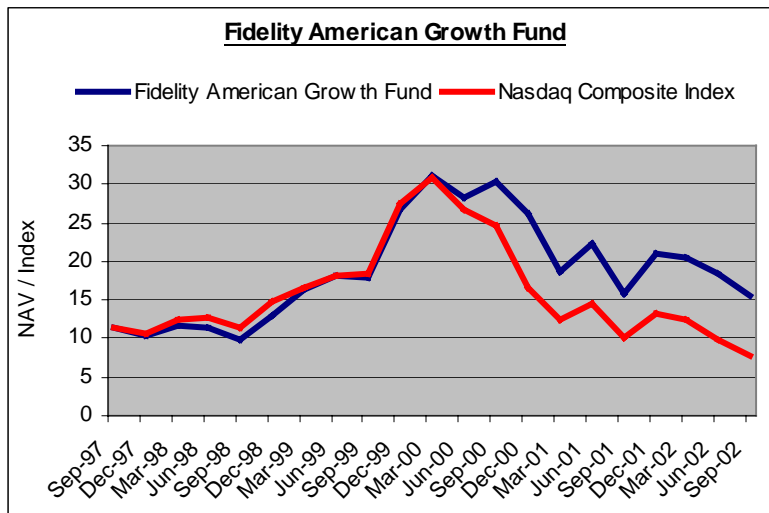
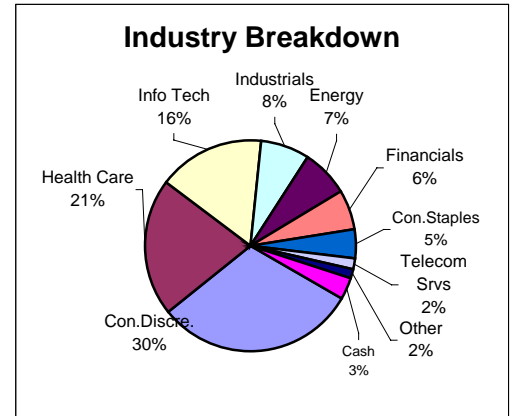
