Investment Philosophy

Capital appreciation through purchasing equity and debt securities at or below their intrinsic value with a secondary objective of achieving a reasonable and growing level of income. The base currency is U.S. dollars. The benchmark for performance is the S&P Barra Value Index.

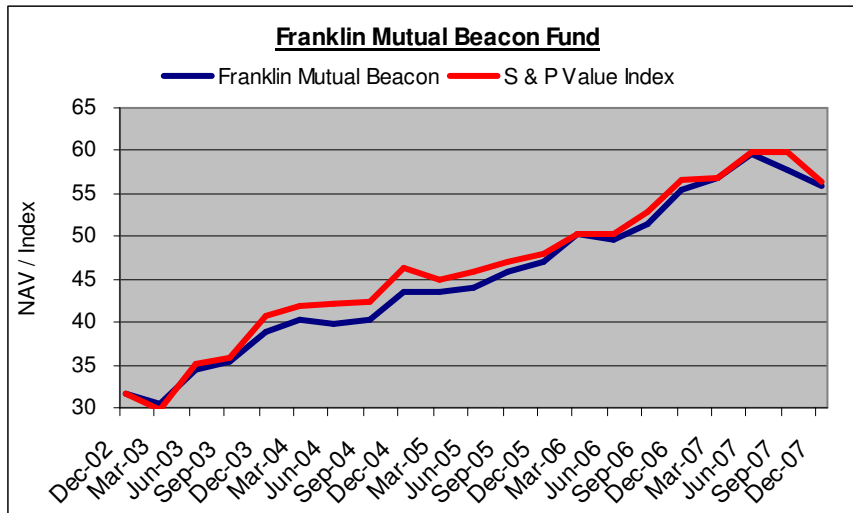
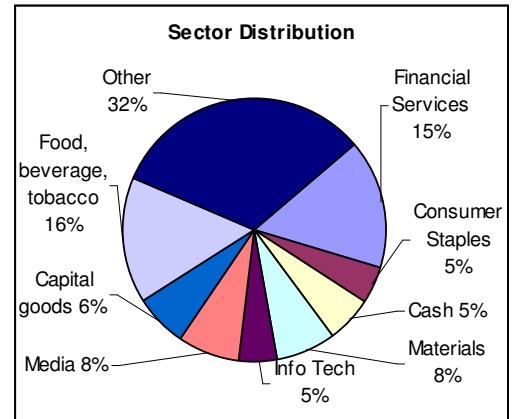
