Fund Philosophy

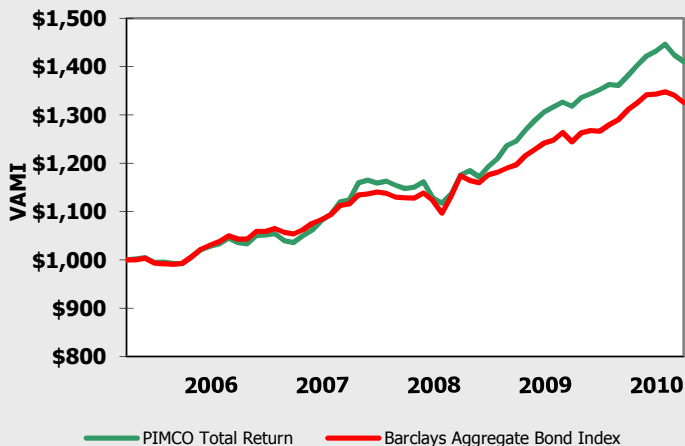

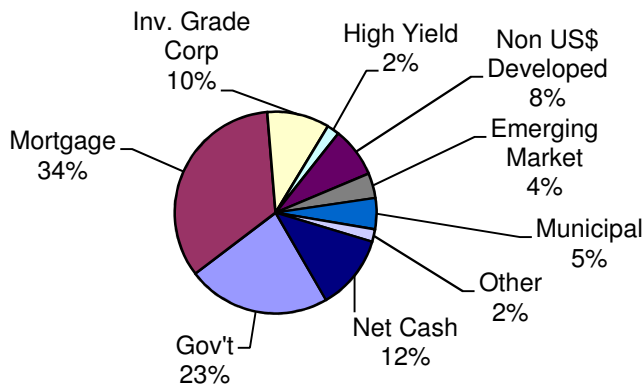

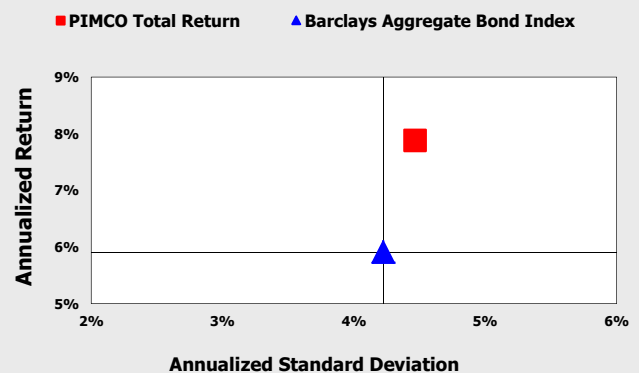
