The fund follows a classic value approach seeking to invest in stocks at the bottom 20% of the S&P 500 index in terms of price to earnings and price to book ratios while focusing on companies with strong fundamentals. The fund invests in companies that they believe have a higher earnings growth potential than the overall market.

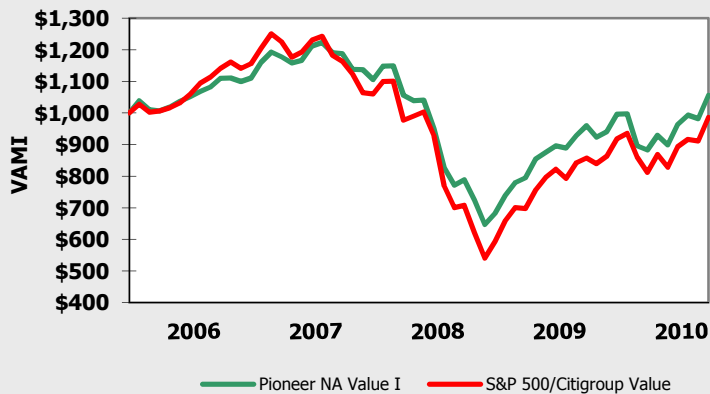

Growth of \$1,000



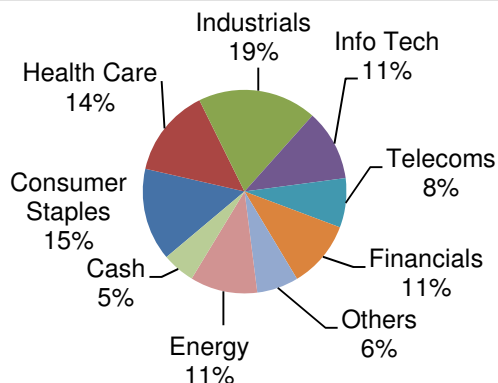

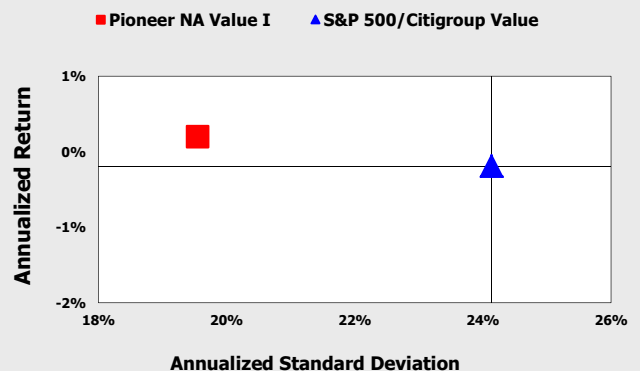
