Fund Philosophy

Objective of the fund is to achieve capital appreciation over the medium to long term by investing in at least two thirds of its assets in North America. The fund follows a classic value approach seeking to invest in stocks at the bottom 20% of the S&P 500 index in terms of price to earnings and price to book ratios while focusing on companies with strong fundamentals. The fund invests in companies that they believe have a higher earnings growth potential than the overall market.

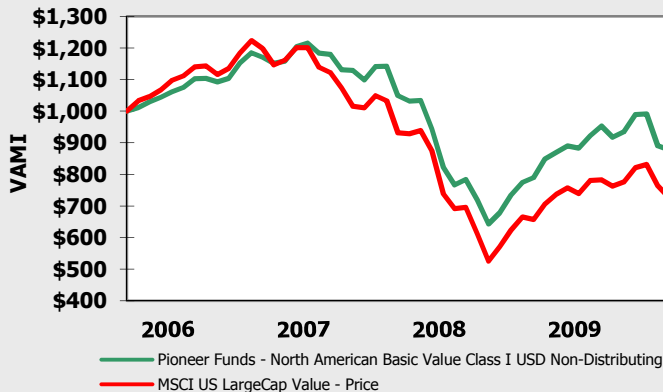

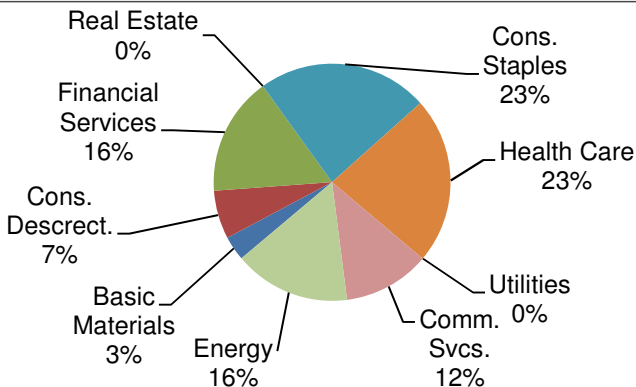

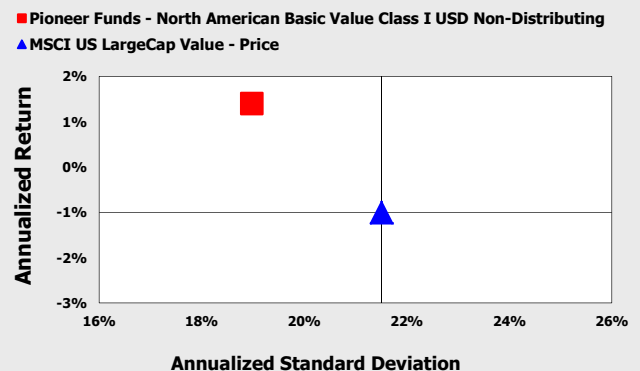
