Is your beneficiary information up-to-date?

By proactively reviewing and updating your beneficiary designations, you are safeguarding the financial well-being of your loved ones and ensuring your wishes are carried out as intended.

What is a beneficiary?

A beneficiary is the person or entity designated to receive your account balance after your passing. You can name one or multiple beneficiaries, including trusts or your estate. It is also possible to designate secondary or contingent beneficiaries in case the primary beneficiary is unavailable. Failing to name a beneficiary can result in your savings going through probate court, a lengthy and costly process.

Why should I keep my beneficiaries up-to-date?

Certain life events, such as marriage, divorce, or the arrival of a new baby, can have an impact on your financial plans and beneficiary designations. As your life evolves, it is essential to review and, if necessary, update the beneficiaries listed on your accounts.

How can I check and change my beneficiary?

It's a simple and convenient process. **Log in to the pension portal** and go to the beneficiary screen. Click the magnifying glass icon, then the Edit button, to make all necessary updates such as name, date of birth, relationship, and beneficiary type (primary or contingent). You can also add contact information for each beneficiary by clicking the "plus sign" next to their name.

Please note: Any changes you make will replace all current beneficiaries listed. You must re-establish all beneficiaries when making changes, as partial edits are not accepted. Although we encourage you to use the portal, you can also **download a beneficiary change form**. If you choose this option, you will need to provide a certified copy of your ID and utility bill.
