



Request to Consolidate Existing BF&M Shareholder

Information Supplemental

All Argus Shareholders received a new Shareholder account for their fractional issuance of BF&M Limited (the "Company") shares.

If you are an existing BF&M Shareholder and your previous Argus registration matches, or is similar to the existing account, this form will authorise the Company to consolidate your accounts. This consolidation ensures that your shares are properly integrated into a single existing BF&M shareholder account, streamlining your holdings for easier management.

By signing this form, you authorise BF&M to combine your accounts into a single account, reflecting all your BF&M holdings, including the newly granted Argus shares.

Important notes

- This form can NOT be used to remove or add a person to your account. Refer to the share transfer section of the website for more information on how to change the registration.
 - Example: Account "John Doe and/or Jane Doe" cannot be changed to "Jane Doe"
- Example of similar registrations:
 - Argus: John Adam Doe
 - BF&M: John A. Doeor
 - Argus: John and Jane Doe
 - BF&M: John Doe and Jane Doe
- This does not guarantee, the consolidation of your accounts. You may be requested to provide additional information and/or documents if deemed necessary.
- This form will only be accepted if signed, dated, and returned with a copy of your photo ID.

The Shareholder Statement and dividend notices are addressed to your Shareholder Registration name.

The Shareholder Statement lists the Shareholder ID number.
